For the Standard/Regular class/es, all dogs will start at the Ratter Level, but dogs with a Barn Hunt Association Open title or higher, may begin trialing at the Expert Level if they prefer.

**Eligibility** - Dogs that are **6 months or older**, on the day of the trial, are eligible to compete for titles. All Dogs must have their current Rabies vaccination. Deaf dogs, 3 legged dogs and dogs in wheelchairs are allowed.

**Bitches in season are not eligible to enter this trial**

## **Exhibitor Information**

All dogs must be kept on a short leash and under control while on trial grounds when not showing. Flex leashes are NOT permitted. Electronic, prong, and choke chain collars are not permitted by HTC. No SMOKING anywhere on premises. Smoking should only be done in your vehicle. Dogs not working MUST be in the car and/or crated. Restrooms are available.
